General Technical requirement:

Posts and Telecommunications Department (PTD) under Ministry of Transport and Communications has responsibilities to check and inspect illegal use of Radio Frequency using by the various organizations within the country, the quality and standard of Telecommunications Network and Wireless Communications Network like Mobile and Microwave communications etc.

Nowadays, with the emergence of new technologies such as 5G, IoT, the applications of radio frequency resources in particular are very diverse. Increasing in the usage of frequencies has also led to an increase in the occurrence of radio interference, resulting in required spectrum monitoring in areas where it is difficult to monitor with conventional equipment. According to the Spectrum Road Map of Myanmar, it is planned to allocate that 700 MHz to 28 GHz for Mobile Communication and 28 GHz for mmWave. Spectrum Rule section 65 mentioned about conventional Microwave frequency ranging from 2–40 GHz with minimum path length. Analyzer with Drone will facilitate the process enforcing frequency used by operators and provider using microwave and mobile system in Myanmar.
